Cancellations after June 30, 2011 will be subject to a \$25.00 cancellation charge. If you have paid for your booth in full, and are unable to attend the 2011 Christmas Show, you must notify us in writing on or before September 30, 2011 in order to receive a refund. A \$25.00 administration fee will be deducted from all cancellation requests received on or before the deadline. Cancellations after September 30, 2011 will be subject to a \$100.00 cancellation fee.
